Oral Comments

Public Comment will be opened during the **Public Comment** time and for **each agenda item** in sequence. Please use the Zoom **“Raise Hand”** feature when the agenda item is announced.

The Chair may limit any individual to 3 minutes. Time to address the Commission will be allocated based on the number of requests received.

Phone attendees: **Press *9 to Raise Hand**

Once your "hand" is raised and it is your turn to speak, the Chair, or the meeting facilitator, will unmute your microphone, then please give your name, and make your comment to the Commission. After your Public Comment, your "hand" will be lowered and your microphone will be placed back on mute.
