under Government Code Section 54953(e) (AB 361), Resolution 22-36

DATE: November 9, 2022

RECOMMENDATION: Adopt Resolution 22-36 approving findings and declaring its intent to continue remote teleconference meetings pursuant to Government Code section 54953(e) due to the Governor's COVID-19 State of Emergency Proclamation and state regulations related to physical distancing.

BACKGROUND: The Board has been conducting its public meetings under the Governor's Executive Orders issued in connection to the COVID-19 pandemic and its related health and safety risks which allowed legislative bodies to hold meetings exclusively by teleconference. Effective October 1, 2021, Assembly Bill (AB) 361 allows local legislative bodies to continue to hold modified remote meetings during a proclaimed state of emergency, if state or local officials have imposed or recommended measures related to physical distancing which warrant holding meetings remotely.

AB 361 codifies certain provisions of the Governor's Executive Orders to allow for the following teleconference rules:

- Waives the requirement that there be a physical meeting location open to the public to attend Board meetings and comment during the meeting;
- Waives the requirement that the agenda identify and notice each teleconference location of each member of the Board that is participating by teleconference;
- Waives the requirement that each teleconference location be accessible to the public;
- Waives the requirement that members of the public be able to address the Board at each teleconference location;
- Waives the requirement that local agencies post agendas at all teleconference locations;
- Waives the requirement that at least a quorum of the Board participate from within the boundaries of the territory of the Board's jurisdiction;

AB 361 imposes additional rules for certain teleconference meetings as follows:

- Agencies cannot require that written comments be submitted in advance of a meeting, and agencies may only close the comment period at the same time it is closed during the meeting.
- The public must be given an opportunity to comment directly during the meeting and public comment periods. There must be a live time, call in or internet based public comment option.
- In the event of a disruption in broadcasting the meeting, the legislative body shall take no further action until meeting access is restored to the public.

In order for the Board to conduct meetings under the AB 361 teleconference meeting rules, the Board meetings must meet one of the following provisions:

- (A) The local agency is holding a meeting during a proclaimed state of emergency, and state or local officials have imposed or recommended measures to promote social distancing; or
- (B) The local agency is holding a meeting during a proclaimed state of emergency for the purpose of determining, by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees; or
- (C) The local agency is holding a meeting during a proclaimed state of emergency and has determined, by majority vote, that, as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.

The AB 361 modified teleconference meeting rules can only be used in the event there is a Governor issued state of emergency. The Governor's COVID-19 state of emergency satisfies this requirement.

The second requirement of item (A) above is satisfied currently as state officials imposed and recommended measures to promote social distancing. California Division of Occupational Safety and Health ("Cal/OSHA") regulations related to COVID-19 recommend physical distancing and regulates "close contact" which occurs when individuals are within six feet of another in certain circumstances.

RESOLUTION 22-36 OF THE NEVADA COUNTY TRANSPORTATION COMMISSION

DECLARING ITS INTENT TO CONTINUE REMOTE TELECONFERENCE ONLY MEETINGS DUE TO THE GOVERNOR'S PROCLAMATION OF STATE OF EMERGENCY AND STATE REGULATIONS RELATED TO PHYSICAL DISTANCING DUE TO THE THREAT OF COVID-19

WHEREAS, the Nevada County Transportation Commission ("NCTC") is committed to preserving public access and participation in meetings of NCTC; and

WHEREAS, all meetings of NCTC are open and public, as required by the Ralph M. Brown Act (Cal. Gov. Code 54950 – 54963, the "Brown Act"), so that any member of the public may attend, participate, and observe NCTC conduct its business; and

WHEREAS, the Brown Act, Government Code section 54953(e), provides for remote teleconferencing participation in meetings by members of a legislative body, without compliance with the requirements of Government Code section 54953(b)(3), subject to the existence of certain conditions; and

WHEREAS, a required condition is that a state of emergency is declared by the Governor pursuant to Government Code section 8625, proclaiming the existence of conditions of disaster or of extreme peril to the safety of persons and property within the state caused by conditions as described in Government Code section 8558; and

WHEREAS, such conditions now exist in the State, specifically, the Governor of the State of California proclaimed a state of emergency on March 4, 2020, related to the threat of COVID-19, which threat remains; and

WHEREAS, California Department of Public Health and the Federal Centers for Disease Control and Prevention caution that the Omicron variant of COVID-19, currently the dominant strain of COVID-19 in the country, is more transmissible than prior variants of the virus, may cause more severe illness, and that even fully vaccinated individuals can spread the virus to others resulting in rapid and alarming rates of COVID-19 cases and hospitalizations; and

WHEREAS, the California Division of Occupational Safety and Health ("Cal/OSHA") regulations at Title 8 Section 3205 recommends physical distancing in the workplace as precautions against the spread of COVID-19 and imposes certain restrictions and requirements due to a "close contact" which occurs when individuals are within six feet of another in certain circumstances; and

WHEREAS, to allow for physical distancing and remote meeting attendance in accordance with recommended measures from Cal/OSHA, NCTC does hereby find that NCTC shall conduct its meetings without compliance with paragraph (3) of subdivision (b) of Government Code section 54953, as authorized by subdivision (e) of section 54953, and that NCTC shall comply with the requirements to provide the public with access to the meetings electronically as prescribed in paragraph (2) of subdivision (e) of section 54953.

NOW, THEREFORE, BE IT RESOLVED, that the Nevada County Transportation Commission hereby submits:

- 1. The foregoing recitals are true and correct.
- 2. NCTC hereby recognizes the Governor's proclaimed state of emergency remains in effect and continues to impact the ability of NCTC and the public to meet safely in person. NCTC further recognizes the recommendation of State and local officials promoting social distancing.
- 3. NCTC shall conduct public meetings in accordance with Government Code section 54953(e) and other applicable provisions of the Brown Act for remote only teleconference meetings.

6. <u>Amendment 1 to the FY 2022/23 Overall Work Program</u> Resolution 22-34

This Amendment 1 to the FY 2022/23 Overall Work Program addresses the reconciliation of the final expenditures from last year and adjusts the estimated revenue carryover amounts. In addition, NCTC, in coordination with Nevada County, was awarded \$230,000 of Rural Assistance Planning grant funding for a planning study to analyze the steps required for electrification of the Nevada County Public Works and Public Transit fleet, as well as potential charging infrastructure at public facilities. NCTC staff is going to be managing that planning study on behalf of Nevada County. The Nevada County Fleet Electrification Study is included in Amendment 1, Work Element 2.4.6, which details the associated planning activities and grant funding.

7. <u>Professional Services Agreement to Develop a Rural Induced Demand Study</u>
Resolution 22-35

This agreement with DKS Associates is to prepare a study of rural induced demand. The theory of induced demand or induced vehicle miles traveled (VMT) is based on urban research of congested highways and the effects of improvement projects. Past research indicated that if a transportation

improvement aimed at reducing congestion adds capacity, then instead of reducing congestion, it would eventually generate new trips and increase vehicle miles traveled. This study is important to Nevada County and other rural counties because the state has applied this theory of induced demand to its state funding criteria, thereby making capacity-increasing highway projects less competitive for funding. Rural agencies such as NCTC have been working with Caltrans and other state agencies to recognize that most capacity-increasing projects focused on safety, operations, and evacuation on rural corridors that are not heavily congested will not result in significant induced demand. This study will help to ensure that the applicability for rural highway projects is appropriately researched, and the study findings can be incorporated into state guidelines as appropriate.

This will be important for future improvement projects in the State Route 49 corridor to ensure that they remain competitive for state and federal funding programs. NCTC is managing this study on behalf of the Rural Counties Task Force, an advisory group to the California Transportation Commission with representatives from the 26 rural regional transportation planning agencies, including NCTC. The \$125,000 is funded through a Rural Assistance Planning grant.

Much of the research on this topic has been conducted on congested, urban corridors, and its implementation in state funding programs disadvantages rural projects. As an example, in the widening of State Route 49 from the Wolf/Combie intersection to the Bear River Bridge, in over 15 years of data the traffic volumes only increased by 0.08%. This study will do a deep dive into the existing research and make recommendations to improve some of the tools and guidance that Caltrans is using. The Project Advisory Committee will have representatives from rural regional transportation planning agencies, some smaller metropolitan planning organizations, the Regional Representatives of Rural Counties, as well as the California State Association of Counties, and hopefully a representative from the Institute for Transportation Engineers. The study results will likely be submitted to the Transportation Research Board for their review, which will hopefully address the issue of changes needed in funding programs and state guidelines. The needed improvements on State Route 49 would have been completed decades ago, if the appropriate formula funding had been available. It has been a struggle to get partner and state and federal funding to complete those improvements.

Commissioner Zabriskie asked if the study would address the extent to which public transportation can help reduce the need and cost of expanding our infrastructure. Mr. Woodman responded that although the study isn't specifically focused on that, it is recognized that especially for rural areas, the best measures for reducing vehicle miles traveled are providing mixed use, smart growth, and multimodal transportation options. The California Association of Pollution Control Officers has done a lot of research looking at ways that multimodal transportation options can mitigate and reduce VMT. Staff has advocated at the state level to increase the Transportation Development Act funding, because for transit to be a piece of the puzzle of reducing VMT and greenhouse gas emissions, the operating funding needs to be at a level that can provide high quality transit service.

Commissioner Arbuckle pointed out that in rural communities, for many people, driving is the best or only option, so the study needs to have a strong focus on making the roads safe and operational. The one size fits all approach that the state takes in its funding criteria does not work for rural communities.

Trisha Tillotson, Community Development Agency Director and Public Works Director for Nevada County shared that from a practical standpoint, the state VMT policies have been flawed and do negatively impact rural counties, so this study is highly needed. Without it, less funding for improvements will be available for our rural county. Other counties are in this same situation and are looking at doing a similar study.

There will be opportunities throughout the study process for the Commission to receive information on the study and provide some input, and a draft plan will be presented to the Commission for review and comments, which can then be incorporated into the plan.

10. Executive Director's Report

NCTC staff will be submitting two grant applications to the California Transportation Commission. These grant applications will be focused on securing funding for phase two of the State Route 49 Corridor Improvement projects, the southbound improvements. Staff will be submitting the funding for the southbound truck climbing lane and elimination of the southbound merge through the Trade Corridor Enhancement Program, and will submit for new access to the Transit Operations Center and eight zero emission buses for the Nevada County Connects transit fleet through the Solutions for Congested Corridors program. Meeting with CTC staff, they seem to be favorable of the projects and the approach, so we look forward to submitting these applications and trying to secure funding to align the southbound improvements for construction in 2026, with the northbound improvements of phase one that are already funded. Commissioner Scofield pointed out that a recent closure of Interstate 80 illustrated how important these projects are for traffic flow and safe evacuation routes.

The California State Transportation Agency (CalSTA), in coordination with the Rural Counties Task Force, hosted the first of several planned workshops focusing on sharing information, identifying challenges and exploring opportunities to help rural communities not be disadvantaged through the implementation of the California State Transportation Agency's Climate Action Plan for Transportation

Infrastructure policies. Executive Director Mike Woodman and Deputy Executive Director Aaron Hoyt sat on the planning committee for the workshop. It is really encouraging that CalSTA wants to initiate an ongoing dialogue to address some of the concerns raised, and to help rural agencies find ways to be more competitive. The upcoming meetings will be a follow up based on the input that was received and they will continue to have conversations going forward.

11. Project Status Report

Sam Vandell, Caltrans District 3 Project Manager for Nevada County, reviewed the September Caltrans Project Status Report.

The turnouts located on Highway 20 and on Route 193 in Placer County have been constructed, so those projects are wrapped up and completed at this time.

Construction has been completed on the culvert rehabilitation on Highway 49 from the Placer County line to north of Lime Kiln Road.

The safety barrier project on Highway 49 in Placer County south of the Nevada County line has been extended, the design will be completed in the winter of 2022-23, and the expected construction will begin in the spring of 2024, with completion in the summer of 2025.

Commissioner Strauss asked what the process would be to see if Caltrans could provide a safety barrier or additional signage on Highway 20 between Grass Valley and Penn Valley, which seems to be a dangerous corridor with a history of accidents and the possibility of hydroplaning in inclement weather. Mr. Vandell commented that putting in a safety barrier would be an expensive process, and getting funding is always a challenge, but he would like to approach the Safety Division and have them do a field review to see what incremental improvements could be done to improve safety in that corridor. Mr. Woodman suggested perhaps a longer term solution could be preparing a corridor plan for SR 20 and get a sense of the desired design that would facilitate safety improvements.

Commission Hoek commented that part of the problem on Highway 20 is the speed that people are driving in that corridor, and that perhaps an increase in highway patrol presence could make a difference. She appreciated how responsive Caltrans has been in addressing the issues that have been brought up on that corridor, and gave kudos to them for the good job they have done on vegetation management in that area.

Commissioner Zabriskie gave kudos to Caltrans for the extension of the on ramp and off ramp at Highway 89 South in Truckee, saying it will be a wonderful safety addition for the town. Mr. Woodman gave appreciation to Caltrans for the vegetation management between Alta Sierra and McKnight Way, saying it was a much needed project and it is great to see the progress.

Alfred Knotts, Transportation and Transit Program Manager for the Town of Truckee, gave appreciation to Caltrans for the coordination and collaboration on projects benefitting Truckee, saying they appreciate Caltrans' support.

12. <u>Closed Session:</u> Pursuant to Government Code Section 54947, Public Employee Performance Evaluation of the Executive Director, Michael Woodman

There was no reportable action during the Closed Session.

RECOMMENDATION: Approve the Western Nevada County Regional Transportation Mitigation Fee Program Annual Report for FY 2021/22.

BACKGROUND: The purpose of the Regional Transportation Mitigation Fee (RTMF) Program is to finance needed improvements to the regional network of streets and roads to mitigate the impact of increased traffic that will result from new development in western Nevada County. The fee program was originally adopted on January 17, 2001 by Grass Valley, Nevada City, and Nevada County and is administered by the Nevada County Transportation Commission (NCTC) through agreements with those agencies.

This Annual Report for FY 2021/22 is provided to assist Grass Valley, Nevada City, and Nevada County in complying with the provisions of Government Code Section 66006, which requires each local agency that adopts mitigation fees to provide an annual report and to schedule a public meeting regarding that report.

The RTMF Program, was last updated and adopted in 2016, established a mitigation fee schedule for regional transportation improvements in western Nevada County. Exhibit 1 shows the Regional Transportation Mitigation Fee area. The fees collected will provide the needed revenue to fund construction of the improvements shown in the RTMF Capital Improvement Program (see Exhibit 2). Exhibit 2 also fulfills the requirements of Section 66006 (b) (1) (F) which requires a local agency to identify the approximate date by which construction of a public improvement will commence.

Exhibit 3 presents a Mitigation Fee Schedule and fulfills the requirements of Section 66006 (b) (1) (B), "The amount of the fee." To document compliance with Section 66006 (b) (1) (G) and (H), there have been no inter-fund transfers or loans made from the RTMF Fund, nor have there been any refunds made pursuant to subdivision (e) of Section 66001 nor allocations pursuant to subdivision (f) of Section 66001.

Exhibit 4, which presents "The beginning and ending balance of the account or fund" fulfills the requirements of Section 66006 (b) (1) (C), Section 66006 (b) (1) (D) "The amount of the fees collected

and the interest earned" and Section (b) (1) (E) "an identification of each public improvement on which fees were expended and the amount of the expenditures on each improvement, including the total percentage of the cost of the public improvement that was funded with fees."

Regional Transportation Mitigation Fee (RTMF) Program Boundary

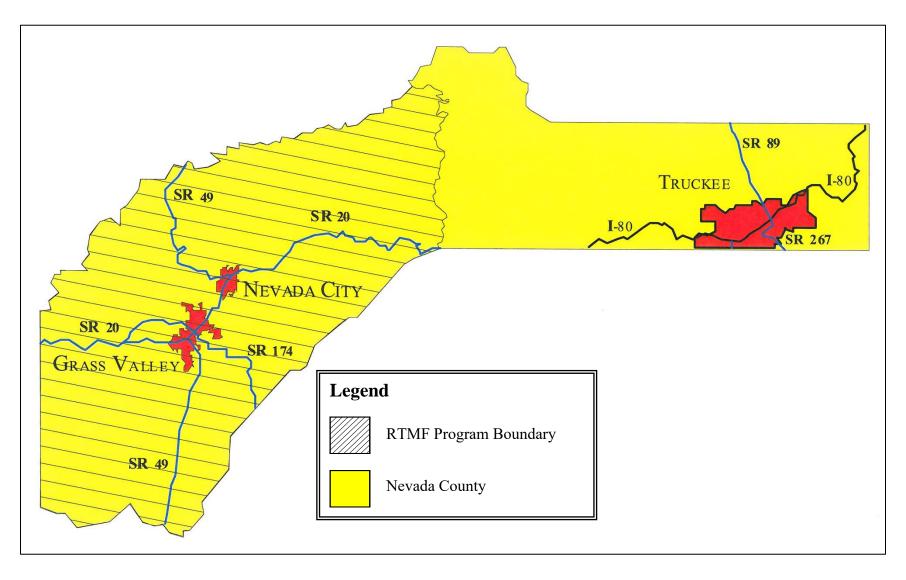

DATE: November 9, 2022

RECOMMENDATION: Approve Resolution 22-37 adopting the Town of Truckee's Transportation Development Act Claim for State Transit Assistance Capital Transit Funding for FY 2022/23.

BACKGROUND: The Transportation Development Act was established in 1971 to provide transportation funding though two different revenue sources. The first is the Local Transportation Fund (LTF) derived from ½ cent of the general sales tax collected statewide and the second is State Transit Assistance (STA) fund derived from the statewide sales of diesel fuel. LTF funds are made available to each jurisdiction based on their percentage of the countywide population and can be used for planning studies, pedestrian/bicycle projects, and transit operational and capital costs. STA fund eligibility is limited to public transit operations and capital uses. STA funds are distributed on countywide population basis (section 99313) to the Nevada County Transportation Commission and on a fare revenue basis (section 99314) to jurisdictions operating a public transit service.

The adopted NCTC Transit Funding Equity Study (2019) provides the framework for the allocation of STA funds. The STA population basis funds (Section 99313) are held by NCTC for existing transit operations, transit service expansion, and transit capital project claims and continue to accrue for future claims.

The Town of Truckee has submitted a TDA claim for \$279,000 of STA capital transit funding for FY 2022/23. The funding is an integral component of the Town's right-of-way purchase necessary to begin construction on the Railyard Transit Center project. The Town has approved a purchase sale agreement and are in negotiations with the property owner.

The Town's claim is in compliance with TDA requirements. However, approval of the claim is subject to the Town Council's approval of the claim and a transit budget amendment to identify the STA funds as FY 2022/23 revenues and expenditures per TDA requirements. The Town Council is scheduled to act on these items at their November 8, 2022 meeting.

NCTC staff recommends approval of the claim. However, the allocation of funds is contingent upon receipt of the Town of Truckee's signed resolution approving the claim, budget amendment, and other necessary forms.

2023 ACTIVE TRANSPORTATION PROGRAM FUNDING RECOMMENDATIONS

On June 15, 2022, the Nevada County Transportation Commission, in coordination with Nevada County, Nevada City, and Grass Valley, and with the assistance of the transportation consulting firm GHD Inc., submitted Active Transportation Program (ATP) Cycle 6 grant applications for the State Route 49 Multimodal Corridor Improvements and the SR 174/49/20 Roundabout and Active Transportation Safety Project.

On October 20, 2022, the California Transportation Commission (CTC) released the staff funding recommendations for Cycle 6 of the Active Transportation Program for both the Statewide funding program component and the Small Urban & Rural funding program component. NCTC staff is happy to report that both of the project applications submitted by NCTC have been recommended for funding, totaling a combined \$19,302,000 in ATP funding. The SR 49 Multimodal Corridor Improvement Project was recommended for \$13.3 million from the Small Rural and Urban funding component, and the SR 174/49/20 Roundabout and Active Transportation Safety Project was recommended for \$5.4 million from the Statewide funding component. The program of projects will not be finalized until the CTC officially adopts the program at its December 7-8, 2022 meeting.

The Active Transportation Program was created in 2013 through passage of Senate Bill 99 and Assembly Bill 101 with the intent to fund projects to encourage increased use of active modes of transportation, such as biking and walking. The Active Transportation Program consists of three funding components: the Statewide funding component (50% of the funds), the Small Urban & Rural funding component (10% of the funds), and the large Metropolitan Planning Organization (MPO) component (40% of the funds).

A summary of the Statewide 2023 Active Transportation Program staff recommendations is summarized below:

Statewide Funding Component

- 67 projects worth \$1.149 billion with \$853.520 million in ATP funding
- 43 projects are Safe Routes to School projects

Small Urban and Rural Funding Component

- 26 projects worth \$209.187 million with \$170.704 million in ATP funding
- 19 projects are Safe Routes to School projects

The one-time, \$1.149 billion augmentation included in the California Budget Act of 2022 significantly boosted the number of projects the Commission was able to fund through the 2023 Active Transportation Program. Without the augmentation, staff recommendations would have only included 23 projects in the Statewide funding component and seven projects in the Small Urban & Rural funding component.

<u>PARTICIPATION ON THE INSTITUTE OF TRANSPORTATION ENGINEERS SENATE</u> <u>BILL 743 TASK FORCE</u>

On October 3, 2022 NCTC's Executive Director was invited to participate as part of the Institute of Transportation Engineers (ITE) Senate Bill 743 Task Force. California Senate Bill 743 was passed in 2013 and implemented in 2018 through the adoption of new CEQA regulations that changed the measure of significant impacts for land use and transportation projects.

The Task Force will be focused on clarifying issues surrounding the analysis of highway capacity increasing projects. The Task Force intends to prepare several technical white papers to help inform state guidance surrounding this issue.

Subject: Truckee Transportation Program Fiscal Year 22/23 Quarterly Update

Since the last update, the Town of Truckee (Town) has been working diligently rebuilding ridership to pre-COVID levels while also working on new and innovative transit initiatives, as well as project development on the Railyard Transit Center and passage of Measure U (formerly Measure R). Updates on these items are highlighted below under each respective heading.

Truckee TART System Update

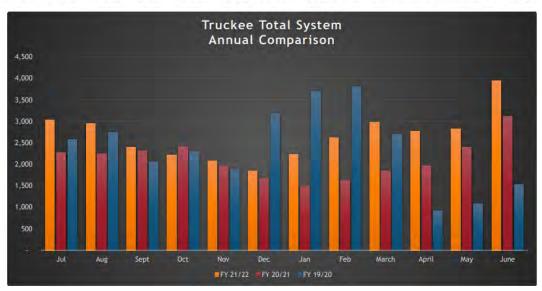
Early in Fiscal Year 21/22 Truckee Tahoe Area Regional Transit (TART), along with many systems across the nation, experienced labor shortages associated with hiring as well as retention of drivers. This resulted in suspension of Fall night service along the State Route 267 and Highway 89 corridors between the Town and resort bases of Northstar and Palisades Tahoe, respectively. To address these issues, the operator, Paratransit Services, increased hiring salaries as well as signing bonuses, which increased interest during the recruitment process. Additionally, the Town took an active role in advertising and recruiting through the Town Human Resources Department and Town portal and outlets which had not previously been done. As a result, the contractor has been successful in recruiting, hiring, and retaining the necessary number of drivers to operate both peak (Dec - April and June – Sept) and off-peak services.

In regard to FY 21/22 performance, the Town is happy to report that ridership is close to or at pre-Covid levels with Truckee TART system ridership. The following chart shows ridership by service type as well as a combination of the entire system.:

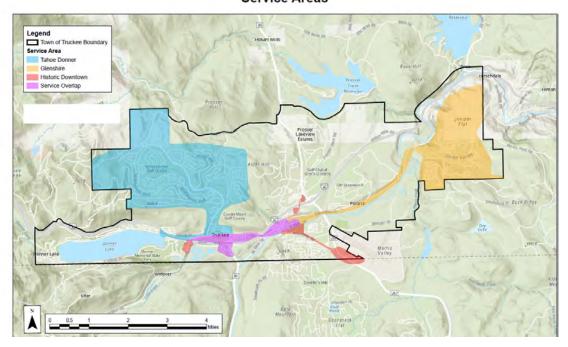

Microtransit Feasibility and Pilot Program

As mentioned in our previous report, the Town was in the process of soliciting the procurement of both a transit planning firm as well as a microtransit operator to assist with planning and launching a "turn-key" microtransit service for Summer 2022. Since that time, Town staff worked expeditiously to procure these professional services as well as form a Microtransit Working Group, secure non-state and non-federal funding (Town funds, Tahoe Donner and Glenshire Truckee Special Service Area funds, Tahoe Forest Hospital, and Visit Truckee-Tahoe TOT Funds), and successfully market and launch a Summer 2022 Microtransit Pilot Program, which served the following area:

Service Areas



Consistent with the Town and Placer County's co-branding of TART, the Town branded and marketed this microtransit program as "TART Connect" in line withPlacer County's microtransit program that operates on the North Shore of Lake Tahoe.

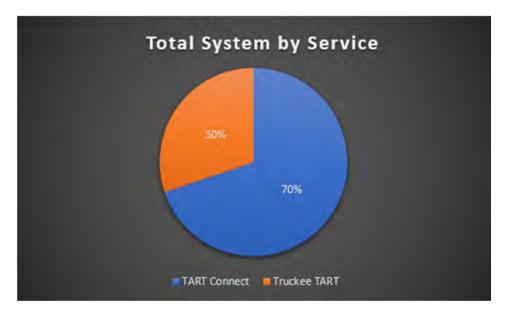


Below is a snapshot of the overall service parameters and performance:

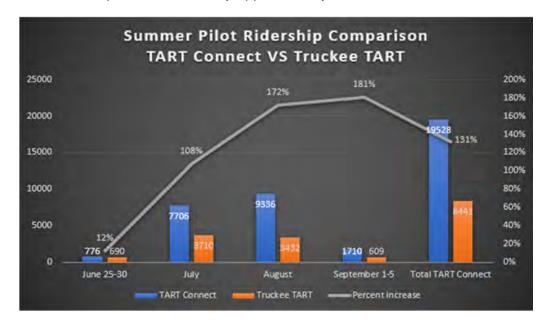

As shown below, TART Connect was highly utilized accounting for approximately 70% of the overall transit ridership during pilot period in which it operated.



Overall transit ridership also increased by approximately 130%.



Given the initial success of TART Connect in the Town through the summer pilot program, Town Staff successfully sought and secured funding from the previous sources in the amount of approximately \$527,000 to fund and launch a Winter 22/23 pilot program. This service will operate from December 15 – April 2 from 8:00 AM – 10:00 PM. Through the pilot period, the Town intends to conduct a thorough feasibility analysis to determine the viability of reconfiguring the Truckee TART system as to operate under a microtransit model. These findings are intended to inform both the Town budgeting process as well as the forthcoming Short Range Transit Development Plan being undertaken by NCTC Staff and in cooperation with the Town.

Railyard Transit Plaza

As the Commission is aware, the Transit Center Relocation Feasibility Study was completed in October 2020 resulting in the identification of the "North Balloon Parcel" as the preferred site/alternative shown below.



At the time of preparing this communication, the Purchase Sale Agreement for this parcel has been finalized and sent to the Seller, Truckee Development Associates (TDA), to initiate the

escrow and closing process. The Town and TDA anticipate closing to be complete in the next 30-60 days. Concurrently with the acquisition process, the Town has been working diligently with the preliminary and final design of Phase 1 with the plans, specification, and estimate at 100% completion.

This Phase 1 design will include all of the civil work including but not limited to the following: pavement for circulation, transit vehicle pull outs for both micro and mass transit vehicles, conduit to support electric vehicle charging and real time transit vehicle location information, space for future public art installation, curb and gutter and pedestrian circulation, drainage, transit shelters, landscaping, and other passenger amenities such as restrooms, bike racks and "fix-it stations," shade structures and benches. Phase 1 is scheduled to be bid in winter 2023 with construction commencing summer 2023.

Phase 2, which design has not been initiated, will be scoped to include the enclosed, climate-controlled transit center structure as shown above. Phase 2 also contemplates the final streetscape amenities, wayfinding, and at grade electric vehicle charging infrastructure. Phase 2 of the Project is not currently fully funded; however, Town will be pursuing several state and federal grant opportunities in FY 22/23 and FY 23/24 with construction anticipated in FY 24/25.

Truckee Trails Sales Tax Renewal Update

As part of the last Town update to Commission, the Town reported that we would be pursuing a voter initiative to renew the Truckee Trails Sales tax measure known as Measure R. Measure R was passed in 2014 and authorized a ¼% sales tax dedicated to the construction and maintenance of trails. Specifically, the ballot language provided for the following expenditure authority:

"Completing the Truckee River Legacy Trail, building and maintaining paved and dirt trails, and protecting the environment and natural open space along trail corridors. Specific uses that would be allowed include pavement maintenance, erosion control, sweeping, litter removal, snow removal and other winter maintenance, and repair or replacement of bridges, signs, bike racks, sanitation facilities, and other amenities."

Measure R has a 10-year taxing authority which meant the measure was set to expire on June 3, 2024. Given the important role trails play in the Town's quality of life, economic vitality, sustainability, overall transportation system, and goals of reducing Vehicle Miles Traveled (VMT) and GHG emissions, the Town proposed a new Trails Tax initiative, referred to this time as Measure U, on the June 2022 Primary Election ballot. Measure U proposed increasing the sales tax from ½% to ½% and proposed to make the life of the tax authorized "until rescinded by voters." Measure U was approved by nearly 80% of the Town voters and is estimated to generate approximately \$3 million dollars annually for the planning, design, construction, and operations and maintenance of both paved and unpaved trails and associated amenities.
