ACTION ITEMS:

 Election of Officers: The Commission will select a Chairman and Vice Chairman for the remainder of 2010. In accordance with the proposed TTALUC Bylaws, election of officers will take place at the first meeting of each calendar year.

Action Requested: In accordance with Public Utilities Code Section 21670.4 one member of the TTALUC will be appointed by the other six members of the ALUC.

3. Adoption of the Truckee Tahoe Airport Land Use Compatibility Plan: This is the same Airport Land Use Compatibility Plan adopted by the Foothill ALUC in 2004, except that the references to "Foothill ALUC" have been changed to "Truckee Tahoe ALUC". There has been no change to any of the technical data. See attached staff memorandum.

Action Requested: Adopt Resolution 10-01.

4. Adoption of TTALUC Fee Schedule: See attached staff memorandum.

Action Requested: Adopt Resolution 10-02.

5. Adoption of TTALUC Bylaws: See attached staff memorandum.

Action Requested: Adopt Resolution 10-03.

6. <u>Drawing of Lots to Determine Terms of Office</u>: In accordance with PUC Section 21671.5(a) The members of the first commission shall classify themselves by lot so that the term of office of one member is one year, of two members is two years, of two members is three years, and of two members is four years. Action Requested: After lots have been drawn, the Chair will announce the term of each member.
